6. Participants' personal data will be stored until the withdrawal of consent. However, withdrawal of consent before the completion of the Festival is equivalent to withdrawal of participation in the Festival.
7. All participants also have the right to access and rectify their personal data, to request the Data Officer to limit the processing of the data, to delete the data or to object to the processing of the data, as well as the right to transfer the personal data.
8. Every person has the right to file a complaint to the supervisory authority.
9. Personal data are submitted voluntarily, but their submission is necessary for participation in the Festival.
10. No automated decisions are made based on the processing of personal data.
